**THE ART OF DECEPTION - KNOWING WHAT IS "REAL" AND WHAT "ISN'T"**

They have been criticizing people like George Alexander, Jim Arvanitis and other luminaries in our field by saying some pretty outrageous things about their lineage, techniques and in a truly idiotic discourse, even attacked someone's hair! (one such attack directed against me personally said that because I incorporate "healing arts" along with my regular instruction that I must be phony!?? – It seems that the moron (and I'm being "nice" here) couldn't comprehend that "healing arts" have been taught SINCE THE VERY BEGINNING OF TIME in the

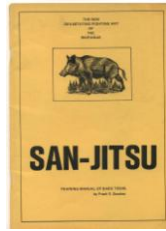
